Being a Bylaw to repeal By-law Number 4-90 and to provide for the delegation of powers and duties pursuant to Section 49, Subsection 1 of the *Municipal Freedom of Information and Protection of Privacy Act, 1989.*

DEFINITIONS:

CHIEF Includes the Chief of Police of the Brantford Police Service, and any officer appointed in an acting capacity as Chief of Police from time to time.

CO-ORDINATOR Includes the person designated as the Freedom of Information Co-ordinator for the Brantford Police Service and the Brantford Police Services Board.
